Tickets

Raffle tickets cost \$50 each or bundled at 5 Raffle tickets for \$200.00. **Online Raffle ticket sale transactions have a processing fee of 2.9% + \$.30 cents, per each transaction.** Raffle tickets must be purchased by eligible ticket purchasers. To be eligible to purchase a raffle ticket, the purchaser must be at least 18 years of age. Amounts paid for raffle tickets for a chance to win are not eligible for tax deductions as a charitable donation. All proceeds benefit Hearts & Horses, Inc.

How to Purchase Tickets

Tickets may be purchased from organization board of members or online at www.heartsandhorses/raffle. When purchasing hard tickets in person, purchasers will receive a raffle ticket stub. If purchasing raffle tickets online, purchasers will receive an email confirmation as receipts of purchase. Hard copies of the ticket stubs are available upon request. Ticket holders do not need to have a hard copy of the raffle ticket to win, nor do they need to be present when ticket is drawn. Tickets will be available to purchase online, ending December 14, 2020.

All Raffle ticket sales are final. Once the vehicle is awarded to the winning ticket holder, Hearts & Horses, Inc. will have no further obligations with respect to the prize.

The winner will be notified immediately by phone and need not be present to win. The winner grants Hearts & Horses, Inc. permission to use his/her name in its promotional and advertising communication. Winner is responsible for any transportation of vehicle from Loveland, CO to their location. Raffle winner must be approved for credit through Ford Motor Credit Co.
